6.	Any aggrieved person by decision of the Secretary general may, make representation to Election Commission.	August 3 <sup>rd</sup> , 2021 Tuesday

24.	<b>Annual General Meeting</b> for official announcement of election results of both Executive Committee & Office Bearers and handing over/taking over ceremony and display of final election results at the Head Office, Zonal Office and website.	September 27 <sup>th</sup> , 2021 Monday
25.	Final results of election 2021-2022 shall be displayed at notice board of the head office and regional offices and website of the Pakistan Advertising Association (PAA).	September 29 <sup>th</sup> , 2021 Wednesday
