

That the election for the Executive Committee of “Pakistan Advertising Association” for the year 2018-2019 has been approved by the Executive Committee in accordance with TOA & TOR, 2013 and election schedule is as follows;

1	Election Schedule to be issued along with Approval of Election Commission by the Executive Committee.	12-07-2018	Thursday
2	Within three days of the Announcement of the election Schedule, Member firms desiring to change their representative shall intimate changes regarding name of representative to the Secretary General along with necessary proof of eligibility.	16-07-2018	Monday
3	The Secretary General shall display within seven days of the announcement of election schedule, the provisional list of all members eligible to vote along with their National Tax Number, Sales-tax number if applicable, the name and National Identity Card Number of their representative. The list shall be displayed at:- Notice board of the head office and regional offices of Association and; Website of Association.	23-07-2018	Monday
4	The members who have any objection to the entries in the list of voters shall send their objections in writing to the Secretary General within seven days of the issuance of the voter's list.	30-07-2018	Monday
5	The Secretary General shall within five days from receipt of objections under sub-rule (4), intimate action on the objections or changes, if any	04-08-2018	Saturday



6	Any person aggrieved by decision of The Secretary General may, within three days of receipt of the decision , make a representation to the Election Commission which shall decide the representation within three days (till 10-08-2018).	07-08-2018	Tuesday
7	Any person. Aggrieved by the decision of the Election Commission or in case the Election Commission fails to decide the representation within the period provided in sub-rule (6), may, within three days of decision by the Election Commission or, as the case may be, on expiry of limitation of the Election Commission under sub-rule (6), make on appeal to the Regulator who shall decide the appeal within ten days (till 23-08-2018) and his decision in this regard shall be final.	13-08-2018	Monday
8	Within two days of the decision of the (Regulator) the final voters' list shall be:- (a) Displayed at notice board of the head office and regional offices of Association; (b) Displayed at website of Association; and (c) Submitted to the (Regulator) Provided that if no appeal has been filed to the (Regulator) the final list of voters shall be displayed within fifteen days (till 25-08-2018) of the decision of the Election Commission under sub-rule (6).	25-08-2018	Saturday
9	Within four days of display of the final list of voters, any person, who is eligible to contest elections for the vacant post, shall end his nomination, duly proposed and seconded by a duly registered voter and signed by the candidates, to the Secretary General.	29-08-2018	Wednesday
10	Within twenty-four hours of receipt of nomination papers, a copy of the final list of voters shall be provided to each contesting candidate.	30-08-2018	Thursday
11	The nomination papers shall be scrutinized by the Election Commission and list of candidates shall be displayed within twenty-four hours of the last date of receipt of nomination papers.	31-08-2018	Friday



12	If any, to nomination of the candidates may be filed to the Election Commission within twenty-four hours of issuance of the list of candidates, which shall be decided by the Election Commission within two days (till 03-09-2018).	01-09-2018	Saturday
13	Within two days of decision of the Election Commission or in case the commission fails to decide within the stipulated time provided in sub-rule (12), any candidate, aggrieved by the decision of the Election Commission or, as the case may be, on expiry of limitation of the Election Commission under sub-rule (12), may file an appeal to the Regulator, who shall decide it within seven days (till 12-09-2018) and his decision in this regard shall be final.	05-09-2018	Wednesday
14	Within two days of the decision of the Regulator the Election Commission shall issue final list of the candidates: Provided that if no appeal has been made to the Regulator, final list of the candidates shall be issued within eleven days of the decision of the Election Commission under sub-rule (12).	14-09-2018	Friday
15	Within five days of display of final list of the candidates, the polling for election of members of executive committee shall be held.	19-09-2018	Wednesday
16	Within two days of the polling as provided in sub-rule (15), any person elected as member of executive committee, shall send, to the Election Commission for election as an office bearer, his nomination duly proposed and seconded by an elected executive committee's member and signed by the candidate.	21-09-2018	Friday
17	The nomination papers shall be scrutinized by the Election Commission and list of candidates shall be displayed within twenty-four hours of the last date of receipt of nomination papers.	22-09-2018	Saturday
18	Within two days of display of final list of the candidates, the polling for election of office bearers shall be held.	24-09-2018	Monday

19	The final result of the election of members of executive committee and office-bearers shall be officially announced at annual general meeting of the trade organization called for this purpose within fifteen days of the date of polling under sub-rule (18) but not later than- (a) in case of the Federation, the 31st day of December of the year; and (b) in case of all other trade organizations, the 30th day of September of the year. The announcement of election results in the annual general meeting under sub-rule (19) shall be the material date for the purposes of paragraph (iii) of clause (f) of sub-section (3) of section 14 of the Act.	29-09-2018	Saturday
20	The final election results announced in the annual general meeting shall be- (a) displayed at notice board of the head office and regional offices of the trade organization within two days; (b) displayed at website of the trade organization within two days; and (c) submitted to the Regulator within seven days	01-10-2018 01-10-2018 05-10-2018	Monday Monday Friday
