Government Affairs Council

During the meeting it was decided to transfer the General Sales Tax (GST) charged on invoices on the agencies as a responsibility as opposed to the advertiser/client. PIO also agreed to process of DROs by PID will take maximum one week and issue of pending bills will review on daily basis.

They also informed that they are also demanding on behalf of PAA to APNS for mandatory requirement for membership of APNS. No application without membership of PAA will entertained and request for APNS membership will be rejected without prior membership of PAA.

Legal Affairs, Taxation & PAS Council

Mr. Ali Mandviwalla, Chairman Legal Affairs, Taxation and PAS Council informed the meeting that he visited FBR Islamabad recently and met officials and hand over the proposal for review on Advertising Agencies, taxation issues and recommended changes in policies in coming budget.
