CANCELLATION OF LICENCE AND EXEMPTION: (Clause 7 of Trade Organization Act 2013)

The licence granted to a trade organization shall be cancelled by the Federal Government where: The trade organization has lost its representative character, or its membership remains below the Prescribed threshold over a period of two years.

REPORTING REQUIREMENTS: (Clause 22 of Trade Organization Act 2013)

A Trade Organization shall annually submit by the 31st December to the Regulator:

- (a) Annual financial statements as prepared by auditors and approved by the Existing Executive Committee.
- (b) Plan of activities for the next year as provided in rule 23 and
