

2.	Last date for receiving changes of names of authorized representatives before Executive Director, if any, in the entries of Preliminary list of members along with proof of eligibility.	July 17 th , 2023 Monday
3.	Executive Director shall display the Provisional List of all members eligible to vote along with their national tax number, sales tax registration number, if applicable, name and CNIC of their representatives and shall display the same on Notice boards, website.	July 21 th , 2023 Friday
4.	Last date for receiving objections, if any, to the entries of the list of voters shall send their objections in writing to the Executive Director. (Ashora Holidays will be observed 27 & 28 July, 2023)	July 29 th , 2023 Saturday
5.	The Executive Director shall intimate action on the objections or changes, if any.	August 3 rd , 2023 Thursday
6.	Any aggrieved person by decision of the Executive Director may, make representation to Election Commission.	August 7 th , 2023 Monday

8.	Last date for making appeal by any aggrieved person upon the decision of election commission or fails to decide within prescribed time before the Regulator of (TO), DGTO.	August 15 th , 2023 Tuesday
