



## CHAIRMAN'S MESSAGE



As I reflect back over the year as Chairman of the Pakistan Advertising Association, I'm reminded of the words, 'tough times don't last, tough people do.' And indeed, the last few years, especially in light of the pandemic, have seen some of the toughest times we have known, on a scale unprecedented in our lifetimes. Unfortunately, the tough times look set to continue with a looming world recession; a war with no end in sight; the devastating impact of climate change; and not to mention the dire socio-economic and political straits we find our own country in.

But just as tough people can navigate even the worst of times, it is imperative for us as an industry to get tough. And that means, we need to improve and fortify ourselves - our vision, our policies, our people, our plans and ultimately, our future.

As a first, I believe that our Association is in what we call, 'survival mode,' and there is an imperative to put our own house in order. At the core, we need to upgrade the Association secretariat to enable it to become more effective – a lack of experience, understanding and industry knowledge routinely undermines the potential of the secretariat to bring more to the table. This need is critical keeping in mind that the executive body of the Association is a voluntary committee, and with the time constraints of its members, its focus remains primarily on policy making. Implementation, data gathering, creating propositions, developing links and relations with stakeholders should be within the ambit and ability of the secretariat. At the moment, that is not the case.

Furthermore, as a whole, our Association has yet to put a stake in the ground in terms of its place in the industry. We still need the right kind of stakeholders on board; wider participation from the mainstream advertising, media and digital outfits; more active relationship building with other associations and bodies – and last but not least, a far more proactive executive committee with their sleeves rolled up to infuse new life and impetus in this Association.

On the external front, this year saw continued acceleration in digital advertising which the pandemic had heralded at a faster pace. And yet, we still need to ramp up digital expertise on agency ends. Meanwhile, on the client side that means that work given to external agencies is being re-evaluated based on these shifting needs and the peeling away of traditional advertising. As an outcome, advertisers are reducing the number of agencies on their roster as part of both belt-tightening and effective brand building. Moreover, in my recent conversations with agency and client-side executives, I have heard more and more about the need for educated, talented young people to enter the Advertising, Media and Marketing industries. The industry is seriously concerned about attracting and retaining talent at all levels.


Another issue is that the advertising industry faces a perception problem – its positive impact on the country's economy; its employment of people, especially strong female participation; its development of the talent pipeline for brand and marketing executives for local and multinational companies; and in recent years the harnessing of digital and new media technologies and skills, are just some of the contributions of our industry that I believe do not get due acknowledgement and recognition. And to make matters worse, the media-government interface and resultant policies are often politically motivated further undermining the industry.

But none of the above issues are intractable or solution-less, and I believe our Association can make a formidable difference if we engage and implement a coherent vision for this industry and bring it on par and beyond some of those in the region.

Towards this end, I want to wholeheartedly thank the committee for bringing me back into the fold and giving me the opportunity to spearhead the Association. My time here has renewed my determination to play an effective role both for the Pakistan Advertising Association and the industry at large.





#### 3) To discuss receivables from PAA Member Advertising Agencies.

Mr. M. Zeeshan Khan informed the house that there is an old recovery issue from our PAA members and we, the four members i.e. Mr. Jawad Humayun, Mr. Waqar H. Haidri, Mr. Rizwan Ashraf and myself have tried on the various occasions during last years and have spoken to them and every time they committed to pay, but have not paid as yet. Actually this is the amount which we have paid to the lawyer and it was committed by the concerned members that they will pay the amount of their part to the PAA on prorate basis. I have also paid the amount of my part. Now we can't understand that how should we deal with them. However, Mr. Ahmed Jamal Mir, Chairman added that in my opinion, if any member cannot pay the Subscriptions and does not clear the dues of the Association, he doesn't have the right to be in the Association and he can't enjoy the privileges of the Association. Mr. Numan Nabi Ahmed expressing his views said that I am surprised to see a name in the list who has to pay a huge amount and isn't there anyone among us who can talk to him to clear the dues? However we will have to look into this matter very seriously but there are few names, to whom I can talk and suggested that we should start from the members whose dues are less.

#### 4) To review progress report from Chairmen of PAA Zones.

- Mr. Mahmood Parekh, Chairman Zone "A" briefing the house about the progress of his zone told that an amount of PKR. 231,000/= is receivable from three agencies who have not paid their subscription. However, he said that I shall try my best to recover &shall personally request them to pay the dues at the earliest and I believe that they will clear their dues soon.
- Mr. Usman Attique Butt, Chairman Zone "B" addressing the Chairman, Mr. Ahmed Jamal Mir told that I have the list of all those agencies who have not paid their subscription; I will call everyone personally and I will ensure that they resolve the matter with compliance to the association regulations.
- Mr. Rizwan Ashraf, Chairman Zone "C" assured that he would talk again to all those Agencies who have not paid the subscription and will try to recover from them as early as possible.

- I. If any client doesn't pay then only the client should be suspended and not the agency.
- II. If any accredited agency of PAA which is not registered with APNS and if a single ad of PAA Member Agency is published, it should be accepted as registered with the APNS and until the dues are cleared, he can't go to any other agency.
  - Mr. Sarmad Ali agreed on above two points. It was also a practice in the PBA. I think that these two issues must be discussed and implemented in the APNS-PAA joint Committee immediately. Chairman, Mr. Ahmed Jamal Mir assured that he will take it up.
- Mr. Usman Attique Butt asked the permission from the Chairman and permission was granted then he told that there is one matter to put in front of the worthy panel that recently an incident happened to me and my counterpart. We both were sharing print campaign of the Federal Government and some pictures of the females were used in the campaign but they were not paid which is the serious copyright violation and it is third time in Islamabad that some ads have been published in which there were radiant or non-copyright images. He further told that violation of the music and copyrights are continuously happening. In this regard with the permission of the chair & rest of the members, I would like to call a meeting in my zone with all those stakeholders who are working with Federal Government.
- The Chairman, Mr. Ahmed Jamal Mir permitted Mr. Usman Attique Butt to go ahead and do that. He further told that all agencies and everybody must know that copyright violation is not permissible.

Mr. Ahmed Jamal Mir, Chairman informed the house that what reason might be the challenge was! we need to strengthen our organization. He expressing his views told that we had a meeting with APNS in 2019 on the following points:



The only thing we can do is to request the members to be careful as everyone has his own business interest & ethics. As all of you know that the Association was completely closed for about ten years and we have worked hard to revive it, so, we have to focus for survival of the Advertising Industry.
- Mr. Rizwan Ashraf agreed with Mr. Sohail Aziz's narrative and said that it is a challenge for PAA to maintain the Association, for which we have to create a code of conduct so that we do not face such problems in the future.
- Mr. Numan Nabi Ahmed also agreed with the narrative of Mr. Sohail Aziz and said that as the Government affairs are going on regarding FBR, PBA and APNS, the PAA played a role beyond its status and all credit goes to Mr. Jawad Humayun and Mr. Waqar H. Haidri specially. I think that Executive Committee has such platform that they can build and I have also told Mr. Ahmed Jamal Mir that what we have achieved in difficult times. There was also a time when no one was listening us and now we have had at least a meeting with the Ministers. As far as Sindh Government is concerned, we got changed the tender twice and told them that you were doing wrong. I think that PAA has certainly achieved a lot in a short period of time and Insha-Allah much more will be achieved in the future, the important thing is that it should be recognized on the Government level that non-PAA members should not be entertained/invited for participation in any tender. Mr. Rizwan Ashraf in continuation of Mr. Numan Nabi Ahmed's narrative added that it should also be made mandatory for PBA & APNS that everyone who is a member of PAA, can get accreditation.

- Mr. Ahmed Jamal Mir, expressing his views said that I have spent about fifteen years with American Council, there are sixty five multinationals but I tell you that the problems we are facing here, the same are also being faced by them. So we all are facing those challenges and need to build up it. He further said that whatever PAA has achieved despite the limited sources, is commendable and for any reason which could not be achieved, we have to think on it. We should only focus on what can be achieved in future.
- In the last Mr. Jawad Humayun addressing Mr. Ahmed Jamal Mir, Chairman, PAA, said that if you feel anything else which is not clear, regarding any matter we as a team are here to help you anytime. He further assured and said that if you have any work for PAA in Lahore or Islamabad we all are ready to support you with open hearts.

The meeting was adjourned thereafter with the vote of thanks to the Chair.

He said unveiling the facts that the advertising industry is already facing considerable difficulties due to the current economic slowdown and the impact of the last year. This amendment will only further exacerbate the industry's issues. More critically, this amendment would dismantle a business practice that has been working well and serving the needs and exigencies of all industry stakeholders - media, private sector and government - and unsettle a business model that has proven fit-for-purpose as well as being financially/legally robust and transparent. He requested to revisit the need to 'reinvent the wheel' for advertising payments through this amendment.





# PAKISTAN ADVERTISING ASSOCIATION, KARACHI NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30TH JUNE, 2022

#### 1. THE ASSOCIATION AND ITS ACTIVITIES

Pakistan Advertising Association ('The Association") was incorporated in Pakistan on 21st February 1981 as limited by guarantee under the Companies Act 2017. The registered office of the Association is situated at Plot No. ST-4, Block-3, Adjacent Gulshan Flyover Opp: T.O. Clinic, Gulshan e Iqbal, Rashid Minhas Road, Karachi. The Association has been guaranteed License No. 211 by the Ministry of Commerce, Government of Pakistan to act as on Association to represent Trade, Commerce industry or services or any combination thereof in advertising sector on all Pakistan basis and to benefit media by establishing sound businesspractices between advertisers agencies.

These financial statements were authorized for issue on 01st July 2022 by the Central Executive Committee of the association

#### 2. ACCOUNTING POLICIES

#### 2.1 Basis of Preparation

These accounts have been prepared under the historical cost convention and are in accordance with requirements of the Companies Act, 2017 and applicable accounting standards.

#### 2.2 Fixed Assets

These are stated at cost less accumulated depreciation, except leasehold land which is stated at cost. Depreciation is charged to income applying the reducing balance method at the rates specified in note 3. Full year's depreciation is charged on all additions whereas no depreciation is charged in the year of disposal.

Maintenance and normal repairs and replacement are charged to income as and when incurred. Major renewals and improvements are capitalized and the assets so replaced, if any, are retired.

Gains and losses on disposal of fixed assets are included in current income.

#### 2.3 Revenue Recognition

Entrance and annual subscription income, service income and rental income are recognized on accrual basis. Membership subscription is accounted on receipt basis for members.

#### 2.4 Taxation

No provision has been made for current taxation as the Association has unabsorbed tax losses.

#### 2.5 Provisions

Provisions are recognized when:

- a) the Association has a present obligation (legal or constructive) as a result of past events,
- b) it is probable that an outflow of resources will be required to settle the obligation and
- c) a reliable estimate of the amount can be made.

#### 2.6 Financial Instruments

Financial instruments carried on the balance sheet include other receivables, cash and bank, accrued expenses and other liabilities. The particular recognition methods adopted are disclosed in the individual policy statement associated with each item.
